**2 Cautions and Limitations**

- A. Not for use in atmospheres containing less than 19.5% oxygen.
- B. Not for use in atmospheres immediately dangerous to life or health.

- F. Do not use this respirator if airflow is less than four cfm (115 lpm) for tight-fitting facepieces or six cfm (170 lpm) for hoods and / or helmets.
