

## Approvals

The half mask shall be approved and certified by the National Institute for Occupational Safety and Health (NIOSH) as a component of a Type C continuous-flow class supplied air respirator (SAR) and/or as a component of a powered air purifying respirator (PAPR) under the Code of Federal Regulations (42 CFR 84) requirements.

## Half Mask

- Same mask can be used with low pressure pumps, high pressure breathing air compressors or EVA PAPR
- Available in three sizes (S, M, L)
